VEHICLE AND RV PARKING ONSITE

GGDC and NCDC charges \$7 parking fee for vehicles each day to help cover facility use costs. Park only on the pavement. Please make checks payable to GGDC (Saturday), NCDC (Sunday). Motor home and overflow parking is in the Day Use parking lot for \$31 per night (no electric/water.)

No dog may be off leash except under the supervision of the judges during the field trial.

RUNNING ORDER

All entered dachshunds must be present on the Field Trial grounds at the time entries close to be officially entered. Late entries will not be accepted. **All stakes will close at 7:30 am.** Drawing of braces will take place at the above listed grounds, and the trial will run at this location on the above listed dates. Absolute will follow the completion of all other stakes. Order of running:

GGDC – Saturday, February 8, 2020 – Open Dog, Open Bitch, FC, Absolute

NCDC – Sunday, February 9, 2020 – Open Dog, Open Bitch,, FC, Absolute

The winners of the Open classes (if eligible) will compete with the winner of the FC class (if eligible) for Absolute. Absolute will be run in braces or as a trio at these trials, to be determined by the Field Trial Committees.

GGDC and NCDC will allow hounds to wear tracking collars at these trials. The collar surface against the dog's neck shall be flat (no protrusions). While the hounds are under judgement, hand-held devices must be turned off. Hand-held devices may be turned on only after the hound has been eliminated from competition by the judges or judgement has ceased. Note that Procedure 3D of the AKC *Field Trial Rules and Standard Procedure for Dachshunds* is still in effect (page 19-20).

NO DOGS ARE TO BE LEFT UNATTENDED IN X-PENS
